

TUITION & FEES 2024-2025

Moves Dance Studio's 2024-25 season begins on August 19th 2024 with open enrollment year-round. We complete our season with an end of year recital in June for students enrolled by January 31st. Summer classes and camps are offered from June-August.

Annual Registration Fee: \$30/Student OR \$45/Family

- 2025 Summer classes are billed as 5 weeks and you will not be enrolled in auto bill for summer classes or camps.
- Tuition is broken up into 11 monthly installments (August-June) based on the number of hours your student dances per week.
- August and June are billed as pro-rated, 2-week months. Pro-rated weeks will not include the multi-class discount
- Tuition rates remain the same regardless of the number of classes there are per month (i.e. you are not charged more for 5-week months or charged less for 3-week months).

Tuition is autobilled to a credit card on file on the 26th of each month for the upcoming month of classes. (Ex. your card on file will be processed on August 26th for the month of September).

Tuition Policies:

- Tuition and registration fees are non-refundable and not transferable
- Registration fee and first month's tuition is due at the time of registration
- Your student will be registered for their class(es) and your card on file charged monthly tuition through May 26th, 2025 (for June's tuition) unless a cancellation form is submitted to Moves (see Moves cancellation policy). June is billed as a 2 week month.
- Missed classes may be made up in any comparable age/level class within 30 days of the absence. No refunds or credits will be issued for missed classes or for class cancellations due to bad weather or pre-scheduled studio closures for Holidays, etc..
- Recital participants must be registered no later than January 31, 2025 and remain registered through June 2025. Costume and related recital fees are billed separately.
- Late Payment Policy: Should payment not be received by the 5th of the month, a \$20 late fee will be assessed. If tuition is not
 received by the 10th of the month your dancer will not be permitted to participate in their scheduled classes until payment has
 been received.
- Moves Cancellation Policy: Students wishing to end their commitment are required to fill out the 30-day written notice form (available at the front desk) to cancel enrollment. Billing and enrollment will cease 30 days from when the written notice is received. Moves considers your student enrolled in the class until we receive this written notice and will bill your account accordingly. We will only accept written notices on the Moves Cancellation form filled out in person. If notice is given less than 30 days prior to cancellation, the customer is responsible for the full upcoming monthly tuition. Tuition will be pro-rated for the month based on the 30-day written notice of cancellation.
- Recital: All registered Moves Students are assumed Recital participants, however, recital is not mandatory. If you choose to opt out of recital you must fill out the "opt out" form that will be included in the first recital packet which will be distributed in Nov/Dec. Recital costumes are not refundable.
